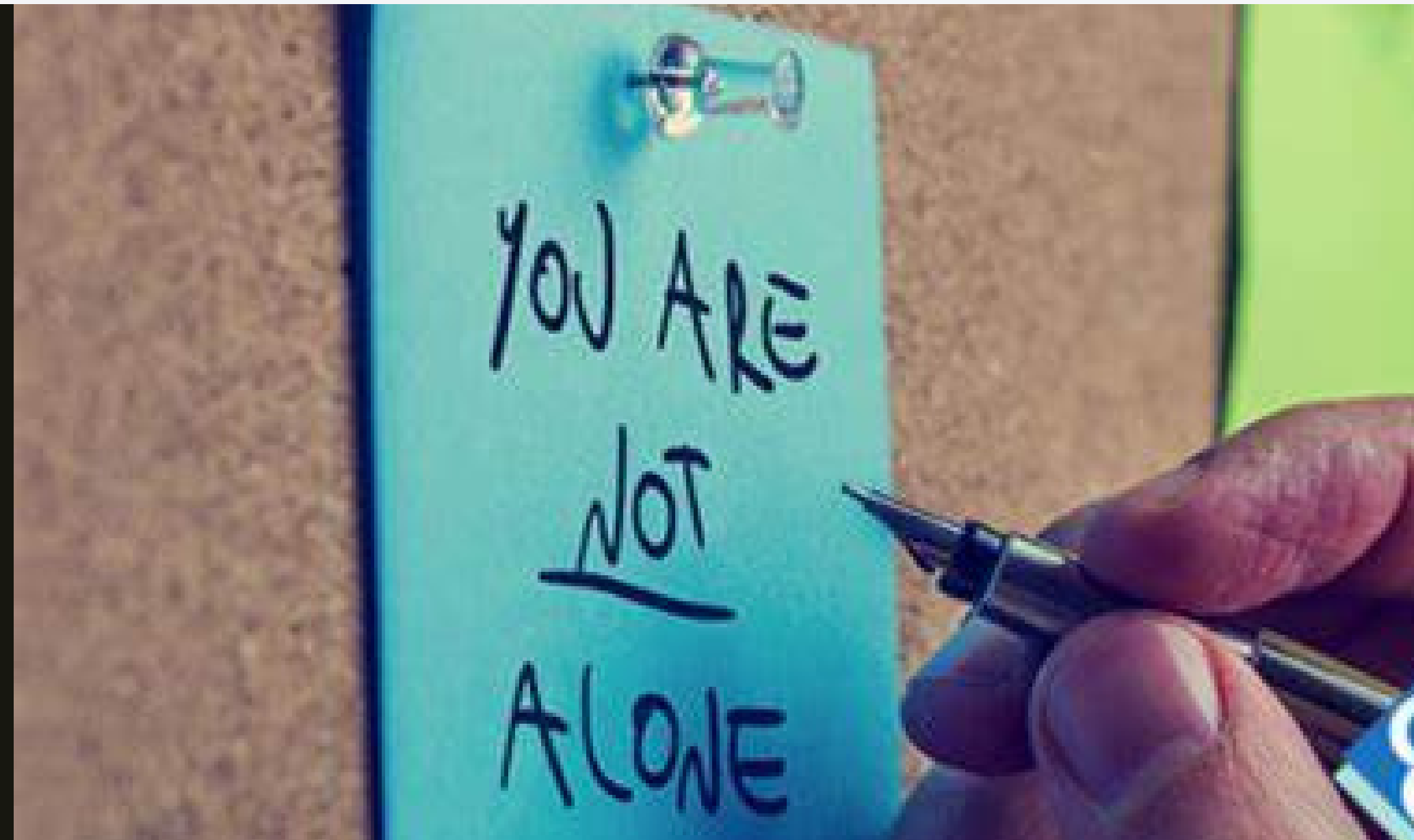

The voluntary sector has an important contribution to make helping the community into becoming a safe place for everybody, in mentoring and turning offenders' lives around;

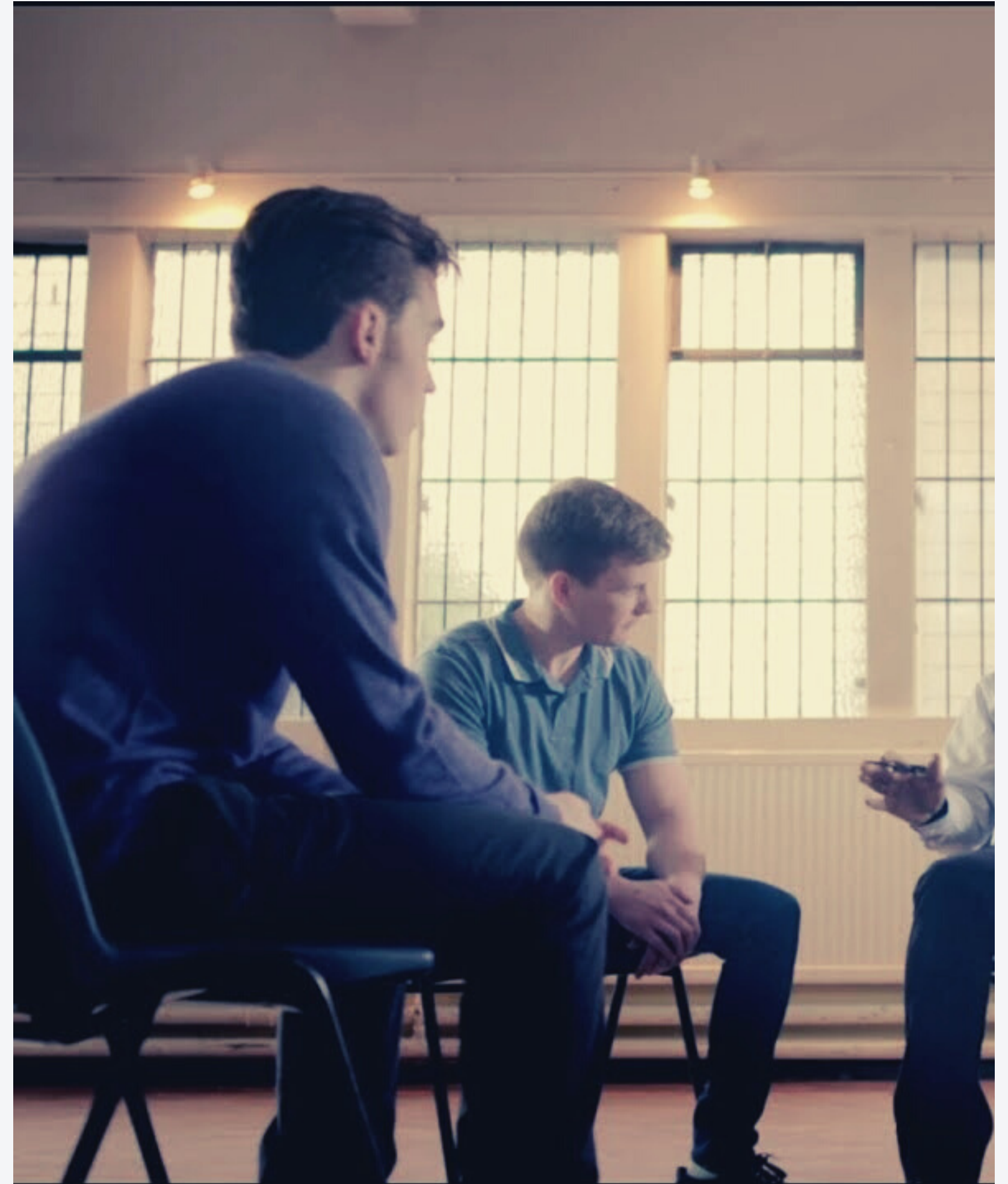
Nothing we do will work unless it is rooted in local partnerships and brings together the full range of support, be it in housing, employment advice, drug treatment or mental health services

Family and significant others

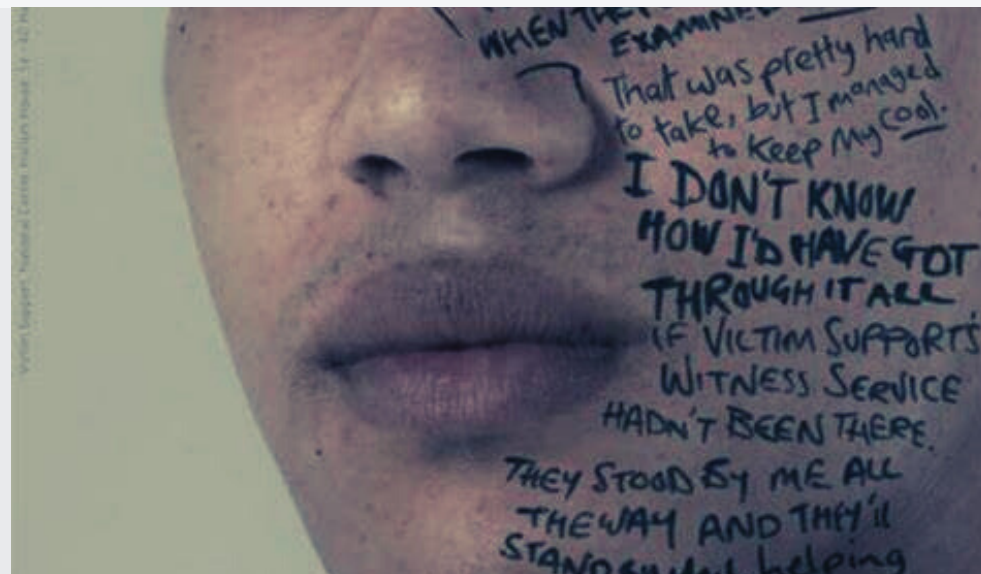
Safe and positive intimate relationships. Improved family relationships/ parenting capacity.

Service Users Journey

Facing the F.A.C.Ts Assessment

Creating Opportunities

- Locating, gaining and keeping a job
- Basic skills, qualifications and effective learning
- How to work with prospective employers/trainers/providers
- Finding, keeping and affording a secure and stable place to live

Boosting

- How partners work together to tackle barriers simultaneously and effectively
- Working with offenders as a specific target, in prison and the community
- Delivering effective provision in a changing and complicated environment of policies, programmes and services.

ON GOING SUPPORT

After completing a course of session

Participants can be categorized into types of people -

- "Implementers"
- "1-dayers"

Implementers'

These people will give the new techniques a try in the days or weeks after the course

1 Dayers'

These people will give it a go 'one-day', and we all know when 'one-day' will come.

1 email each month reinforcing a single concept from the course – ensuring the learning continues

2. Free Re-sit

Each participants is welcome to join in our local Enterprise club for 12 months after the original course date

3. Reference - After completing our course participants receive self-employment support (Business Mentor) for 6 months



Last Year's Outcomes

Recent figures show offenders serving sentences of less than 12 months had a re-offending rate of nearly 65% - laying bare the need for robust community alternatives..



This Year's Aims

By having Going Equipped as one of the consistent services delivering end-to-end offender management, sentencers can feel confident that alternatives to ineffective short custodial sentences will be delivered robustly..
